Official Contest Rules

1. Name of Sponsor & Administrator

2. Eligibility

The Father’s Day Contest is open to all individuals age 18 and older who are legal residents of the United States and Canada. Valid identification may be required.

Upon winning, participant must also complete the additional registration forms which include a Photography/Video Release and Hold Harmless Agreement and sign a copy of the Official Rules acknowledging receipt and acceptance. Only one (1) entry per person will be permitted regardless of the method of entry. The submission of duplicate entries by the same entrant will be automatically withdrawn.

Entrants will be notified by Facebook messenger. Winner entries will also be posted on our LED screen for Father’s Day weekend.

3. Prizes. A total of two (2) prizes will be awarded in this Contest as follows: The prizes are Yeti Coolers valued at \$199.99 Each. Winners must claim their prize in person with a valid photo ID by July 30th, 2018.
